Well, folks, another spring has sprung and here are a couple highlights that have happened or are going to happen in your great township. The Park Pavilion, Restroom and Concession Stand Project is now complete and is open for public use. The restrooms are open from dawn to dusk every day of the year and are heated for the winter months so no more Port-a-Johns. There is also a small concession stand that has a refrigerator, pizza warmer, hot dog roller and gas grill. The concession stand and pavilion can be rented for \$100 each and a \$200 deposit will be required for the concession stand. This beautiful facility is available to Lawrence Township and Canal Fulton residents only.

POLICE DEPARTMENT

Officer and township resident, William Yerman will be retiring after 21 years with the Lawrence Township Police Department. Bill, you will be truly missed. Please enjoy your retirement.

ROAD DEPARTMENT

The Lawrence Township Road Department has a busy summer berming the roadways. This process requires cutting back the side of the road (grass area) so that it is not higher than the actual roadway itself. This is needed so the water can run off the road and into the ditches. The road department has completed approximately 20 miles of the townships 120 miles of roadway.

FIRE DEPARTMENT

Finally, our great Lawrence Township Fire Department will take delivery of a new ambulance towards the end of 2024. The township has set goals on replacing major vehicles such as ambulances, police cruisers and plow trucks every 10 years.

All "Transient Vendors" who do business within the unincorporated area of Lawrence Township, Stark County, Ohio, shall register with the Township at the Lawrence Township Administrative Office at 5828 Manchester Avenue, N.W., North Lawrence, Ohio 44666, between the hours of 8:00 a.m. and 3:00 p.m., Monday through Thursday except holidays.

DEFINITIONS

"Transient Vendor" means any person who opens a temporary place of business for the sale of goods or who, on the streets or while traveling about the township, sells or offers for sale goods, solicits orders for future delivery of goods, or attempts to arrange an appointment for a future estimate or sales call. "Goods" means goods, wares, services, merchandise, periodicals, and other articles or publications.

EXEMPTED BUSINESSES OR ORGANIZATIONS

Persons selling items for any project sponsored by an elementary, middle and high school, and/or churches, and/or youth sports groups, and/or scouting groups are exempt from obtaining a permit.

TRANSIENT VENDOR FEE

Transient Vendors shall make a payment of \$35.00 via check or money order made payable to Lawrence Township or exact cash for the registration fee.

LENGTH OF PERMIT

The Transient Vendor registration and permit is valid for one (1) year.

DOOR-TO-DOOR

Between the hours of 10:00 a.m. to 7:00 p.m. or sunset (whichever is sooner) Monday through Saturday.

No solicitations are to be made on Sundays or holidays.

NO SOLICITATION

Transient Vendors shall not sell, offer for sale, or solicit orders for goods where the owners and/or occupants of a dwelling, building or other structure that has posted a notice by means of a sign that its owners and/or occupants do not want Transient Vendors to enter upon the property, and such sign is reasonably placed by its size and position to notify the Transient Vendor.

TRANSIENT VENDOR CREDENTIALS

Transient Vendors will be issued a permit number and must always carry that with them. If asked, they must produce that number as proof that they have registered with Lawrence Township.

If you have questions about a Transient Vendor that solicits at your property, you may call the Lawrence Township Administrative Office at 330-854-3830 or call the Lawrence Township Police Department.

Aluminum Cans for Burned Children (ACBC)





Open Burning

Open burning is any set outdoor fire that does not vent to a chimney or stack.





the exclusionary text are met. This code is under authority of the Ohio Division of Forestry. Knowing the type of fire permitted for your area is a good idea. The Ohio EPA determines the types of fires restricted inside and outside a

village or city. For most, open burning of residential and land-clearing wastes is prohibited within city limits. Restrictions do not apply to barbeques, campfires, cookouts, and bonfires (with wood stacks no larger than 2ft. high X 3ft. wide) ñ these types of fires are permitted.

For additional questions about Ohio's open burning regulations, contact the Ohio EPA Division of Air Pollution Control at (614) 644-2270. Local EPA districts are also available to answer questions. Their website contains a complete list of agencies available in the state: epa.ohio.gov/dapc/general/openburning. The Ohio Department of Natural Resources also has more info on their website at forestry.ohiodnr.gov/burninglaws.

North Lawrence Fire Dept. Updates



What's Happening

- The NLFD has seen a significant increase in call volume since January 1st, at the current call rate we are projected to see run totals the NLFD has never seen before.
- In January, the NLFD established a Search and Rescue Division that is one of a kind, not just to Stark County but the State of Ohio. This team consists of national registered Search and Rescue Technicians certified through the National Association of Search and Rescue (NASAR). The team is currently seeking monetary donations to help obtain new specialized equipment.
- New Medic 8 has been signed for! The NLFD has signed a contract with Medix to purchase a new ambulance. Expected delivery is set for October! This unit is being paid for by our own fundraising just like Engine 2 was!
- · Recently our own Halligan the Firedog made a donation to Lawrence Township Police Dept. K9 Noa to help with supplies and vet visits.

Residential Building Requirements

Steps for an addition to a residential home, an accessory building, deck or pool with septic system:

- Septic approval/permit from Stark County Health Department
- Zoning permit from Lawrence Township Zoning Department
- Building permit from Stark County Building Department

Steps for an addition to a residential home, an accessory building, deck or pool with sanitary sewer:

- No permit from Stark County Health Department is necessary
- Zoning permit from Lawrence Township Zoning Department
- Building permit from Stark County Building Department

If your accessory building or shed is less than 100 square feet (10'x10') you will **not** need a Health Department permit, Zoning permit or a Building permit.

Drainage Desk: What is a Sinkhole?? By Isabelle Bruder

A common type of drainage call we receive is about sinkholes. While these typically are not "true" sinkholes in the geological sense, they are depressions that form in the ground due to burst sewer lines, abandoned mines, buried and rotting debris, rotting tree stumps, or buried rocks from construction. Water leaking from a pipe or filtering through the ground eats away at loose layers of soil, creating an underground void. When these voids become large enough, the soil and grass will collapse to form unnatural holes that we commonly refer to as sinkholes. If you notice a sinkhole in your yard, take caution around the area and do not enter the sinkhole as this can lead to serious injuries. In most situations, these can be repaired by the homeowner, but it is recommended that a professional determine the extent and cause of it. Here at Stark Soil & Water, we can pull up existing sewer pipes and mines maps as well as visit your property to help determine the cause of the sinkhole. Since we are not professional geologists though, we cannot give recommendations on how to fill the holes - true sinkhole or not. To fill the sinkholes, we can provide you with a list of professionals to contact that know how to do it correctly and safely.

A common question with sinkholes is determining who is responsible for the repair. According to Ohioís drainage law, if the cause of the sinkhole, such as a burst sewer pipe, lies on a private property, then the owner of the said property is responsible. This holds true even if the problem such as a pipe or buried debris was not installed by the property owner. At Stark Soil & Water, we can look at your property and research any existing county storm sewer pipe lines or abandoned mines to help determine the cause of the sinkhole. We can then direct you to professional geologists and contractors that can help you fill in the hole and reduce the risk of sinkholes on your property.

While there are thousands of sinkholes in Ohio, they only exist in about 2% of the central and western portions of the state, making it extremely unlikely that residents of Stark County will ever see a true sinkhole. If you see a hole in your vard that shouldn't be there don't he itate to give us a call and get it checked out. They can be dangerous, and our goal is to help you find the right solution.

A MESSAGE FROM Mayor William (Bud) McDaniel



Welcome to springtime in Clinton Ohio. At the village hall, we are working on issues with the train and have met with Ohio State Senator Kristina Roegner. She has worked with a very similar issue in Hudson and by the time you get this newsletter, we will have met with the Hudson City Manager to review what they have done for their city. Now that trains and safety are in the spotlight, this may be a good time to get state and federal resources pointed our direction. I also had the opportunity to speak with Emilia Sykes at one of our breakfast meetings and she is very interested in helping us

out. There have been many suggestions and our budget may not allow for all of them, but it will be interesting to find out what is possible to ease the congestion of a stopped train.

Speaking of trains, I'm sure that some or most of you are familiar with the rails to trails programs all across our country. Wayne county rails to trails has been working on the Heartland trail that is utilizing the railroad bed that connected Clinton to Orrville. Most of this has been built and I have ridden it many times on my bike rides to Orrville and beyond. The final stage will be under State Route 21 through Warwick and connect to our towpath trail in town. The connection to Warwick is expected to be completed in 2026 provided they get their funding. I have signed a letter of support that we hope will aid in the necessary grants to make this happen.

Let's keep in mind our veterans park in Clinton. They are open year round. The Hall of Heroes pavilion is open as we have volunteers to man it. The interior went through a complete remodel in January and there are quite a few changes. March has two veteran associated events and they are the National Medal of Honor day on the 25th and the National Vietnam War Veterans day on the 29th. After the parade and memorial service at the cemetery this year, stop by the park and take a look at all we have to offer.

One last note that is making the big news this year is the solar eclipse on April 8th. For most of us, it will be a once in a lifetime event. I have seen two in this area with the last one occurred on August 21, 2017. But what is considered a total solar eclipse for us in Ohio last occurred in 1806 and the next one will be in 2099. With this 124 mile wide band moving through Ohio, the epicenter to hit Cleveland at 3:15pm. At this time, hotels are being booked solid for out of town visitors to experience this with us. Many areas are sponsoring events that day. The Spaghetti Warehouse in Akron is one of them. I only mention them because their parking lot is along the towpath trail about 10 miles from us. Our summit county public health director, Donna Skoda, is recommending that we stay off the road during this time. Might be a good day to bike to Akron to see this. Our area hospitals are gearing up to take in a lot of people with retina damage from looking at the sun. Glasses are available and I just ordered a 12 pack from a popular website that most of you may be familiar with. Stay safe and if you must travel to an eclipse event, plan to get there early and leave late. I have heard that riding the metro in Akron will be free that day, so plan ahead. Have a great spring and see you at the parade.

In the past, the Village of Clinton has maintained the same regulations and guidelines, concerning fireworks as the Ohio Revised Code. That code prohibited the private use of fireworks without proper permit.



Thus far, Village of Clinton's Code has not changed. It is up to the each individual municipality to decide whether or not to adopt the change, in the ORC, concerning fireworks. The Laws, Ordinances, and H. R. Committee, is considering whether they feel it is in the best interest of the Village, to change the current Code to match the current ORC. Once they make that determination, the Committee will make a recommendation to Council. The new Committee Chair is Rita Joseph with Ellen Conroy and Matt Steiner as members. Feel free to reach out to them or any other Council members with your comments or concerns.

From the desk of Mayor Joseph Schultz

Hello fellow community members. I hope and pray your 2024 is off to a prosperous start full of good success. This year will be a big deal for our nation as we select our president for the next four years and it will be the longest campaign season in history as the candidates try to sway undecided voters. This year will be equally important on a local level. Our goal is to get

your support to build a combination full and part-time Fire Department. My goal is to accomplish this improvement with a cost neutral approach. The way to achieve this goal is to ask you the voters to pass a levy that will take the current millages dedicated to the Fire Department building and equipment and roll them CANAIL FUILTON into one new operating levy. The new levy will be egual to the amount of the two levies. The amount of that millage will be available to us from the County Auditor sometime this summer. The building levy will

be paid off in early 2025 and equipment levy expires in 202 . First of all, I want to explain the need for a more stable staffing

model. Currently, we work collectively with Lawrence Township to staff five people 24/7 with a minimum of two of the five being a paramedic. Consequently, we can answer two calls at the same time with at least one paramedic assigned to each call. The City of Canal Fulton pays for 12 of the 24 hours and Lawrence Township pays for the other 12 hours. THAT WILL NOT CHANGE. All of the employees are part-time except for one Assistant Chief who works 40 hours per week to oversee staffing, administrative duties and fill in for call offs. The full-time Assistant Chief is Lawrence Township's employee, but the city reimburses the township for half of his salary and benefits. The problem we need to address is that being a parttime department that depends on personnel who are full-time employees in other departments, we CAN NOT require part-time employees to show up for scheduled shifts. When our part-time

personnel who work full-time in another department are required to work overtime in that department, they have HE CITY ON to call off from our shifts, thereby leaving us short staffed.

Currently, we have 56 employees; 38 of them are certified paramedics, 6 are paramedic students and 12 are basic firefighters. We require them to work at least one 24 hour shift per month to stay on our payroll. See the table in this issue to learn who they are, certification and years of dedicated service to our community. From our pool of 38 paramedics 37 of them are employed full-time at other departments. Another telling statistic is that, we had 11 people resign in 2023. Ten

of them were paramedics who left because, they no longer wanted to work part-time while working full-time elsewhere. I plan to meet with numerous stakeholder group and individuals leading up to the November election. 
